Covid-19 New Requirements

With the recent updates from the State Government, there are several new requirements in place for Mirrabooka International Softball Stadium from January the 31st, 2022. Our complex is classified as a Hospitality venue, with a large liquor licensed area, proof of vaccination will be required to enter licensed areas of our venues, this includes purchasing of alcohol. Masks are required for any indoor facilities.

Individuals will be stamped at the front gates once proof of vaccination is shown to Covid-19 Officers. Delays at the bar or canteen will not occur as those who are not vaccinated will not be permitted in the licensed areas.

To purchase alcohol, individuals will be able to show the stamp they got at the front gates to purchase alcohol, if over the age of 18. Alcohol is not to leave the licensed area, and thus cannot be given to unvaccinated individuals.

Advice for Unvaccinated Players, Umpires, Coaches and Scorers

Unvaccinated players, umpires, coaches, and scorers are unable to enter the licensed area marked in our venue (In Yellow). It is therefore necessary for these individuals to follow the areas outlined in this guide to avoid entering our licensed areas, to still be allowed to play on our Diamonds. These diagrams can be found at the end of this document.

Some individuals will need to wait for the conclusion of games to travel to their designated dugout.

Unvaccinated Spectators will not be allowed to enter our venue.

Softball WA will incur a \$50k fine and the loss of a liquor license if we are not compliant with covid-19 hospitality rules. Unvaccinated individuals pose a risk to the potential financial health of our sport if they do not comply. We are already making concessions for allowing unvaccinated individuals into our facility, we are prioritising those who are currently involved in the sport to continue to play. Limiting the time of individuals who are unvaccinated are at our facility greatly decreases the risk undertaken by Softball WA.

Upon completion of games, unvaccinated players, umpires, coaches, and scorers are to exit following the same path that they travelled to their diamond. These unvaccinated individuals are required to leave the premises upon the completion of their game. These individuals can quickly move across the Diamond between innings to leave the venue.

Mirrabooka toilets and changerooms are not allowed to be entered by unvaccinated individuals, as they must enter a licensed area to get to these facilities, so they are instructed to use Herb Graham facilities.

Bags are not to be rolled or dragged across Clay diamonds; they are required to be picked up.

Penalties for Disregarding these Rules

If members are found to not abide by these rules set out by Softball WA for the Mirrabooka International Softball Stadium, several actions may be taken against an Individual or Club.

For an individual:

- Automatic Removal from the Venue.
- Potential Ban from the Venue.
- Review of their Softball WA membership.

For a member or spectator of a Club:

- Penalty imposed to the club.
- Penalty imposed to the team or teams of the associated individual.

Individuals or teams found helping others break these rules will also be punished.


Diagram Legend

Blue Arrow: Designated path required to be taken by all unvaccinated players, umpires, coaches, and scorers traveling to the indicated diamond


Red Arrow: Designated path required to be taken for the Home Team on Diamonds 1 & 2 and for the Away Team on Diamond 3 & 4.

Yellow Area: Licensed Area


Diamond 1
